

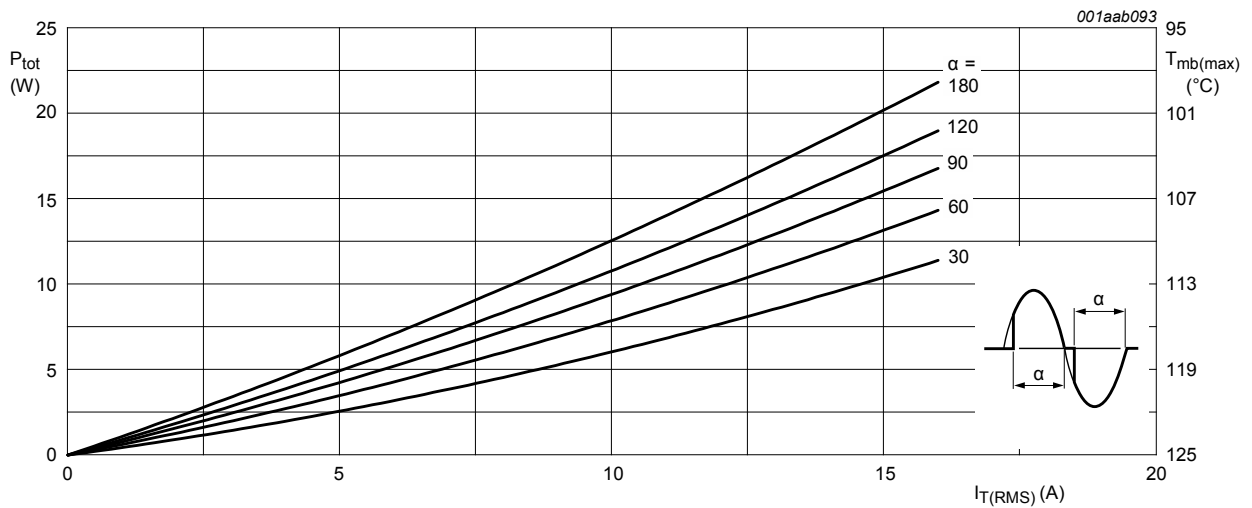

Fig. 1. RMS on-state current as a function of surge duration; maximum values



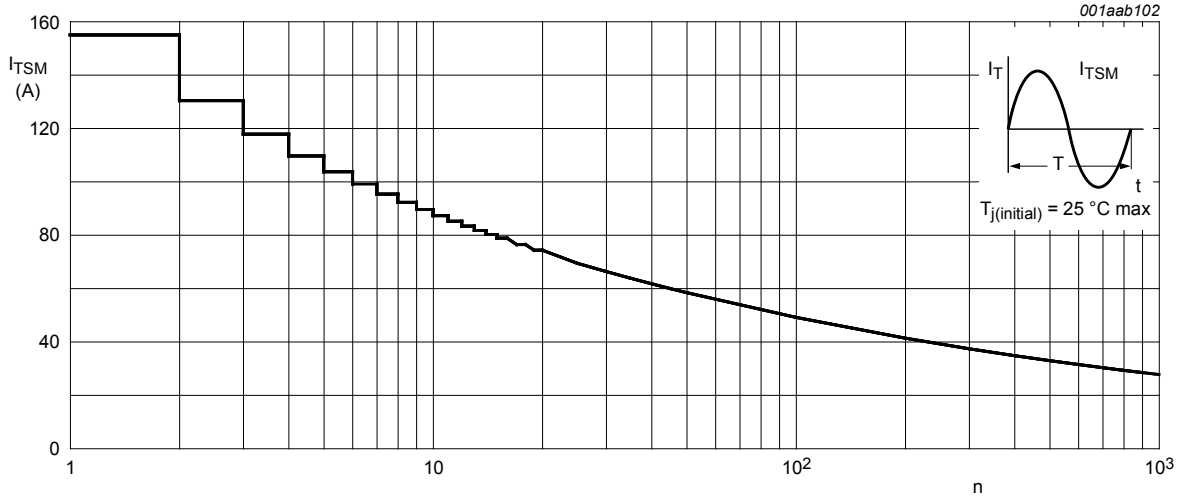

Fig. 2. RMS on-state current as a function of mounting base temperature; maximum values



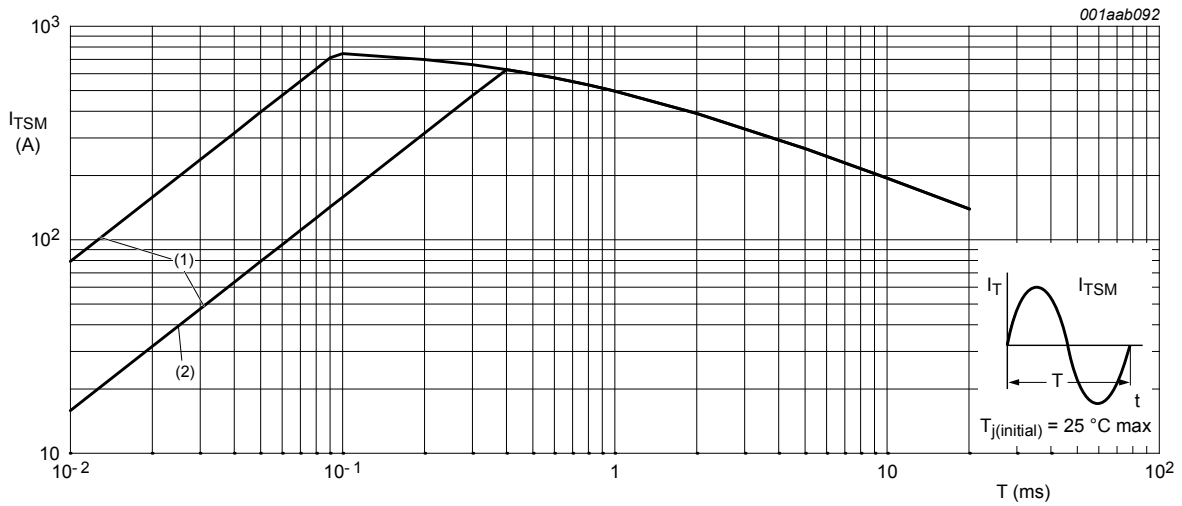
$\alpha = \text{conduction angle}$

(1) dI_T/dt limit

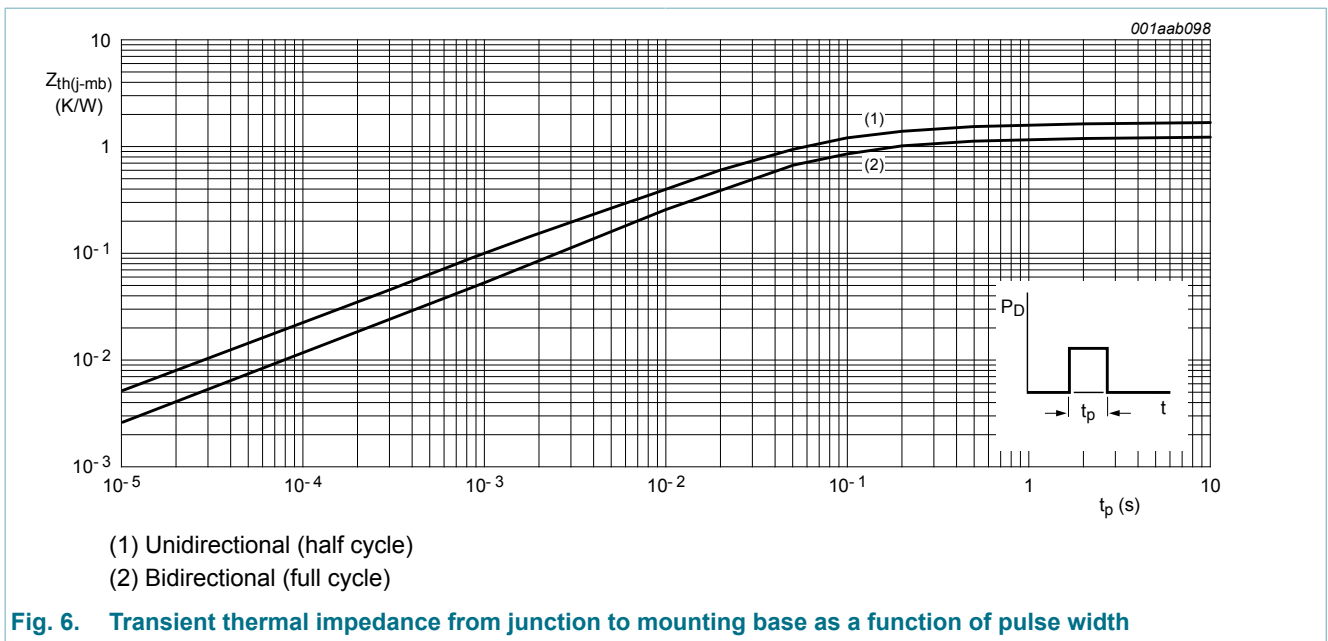
(2) T2- G+ quadrant limit

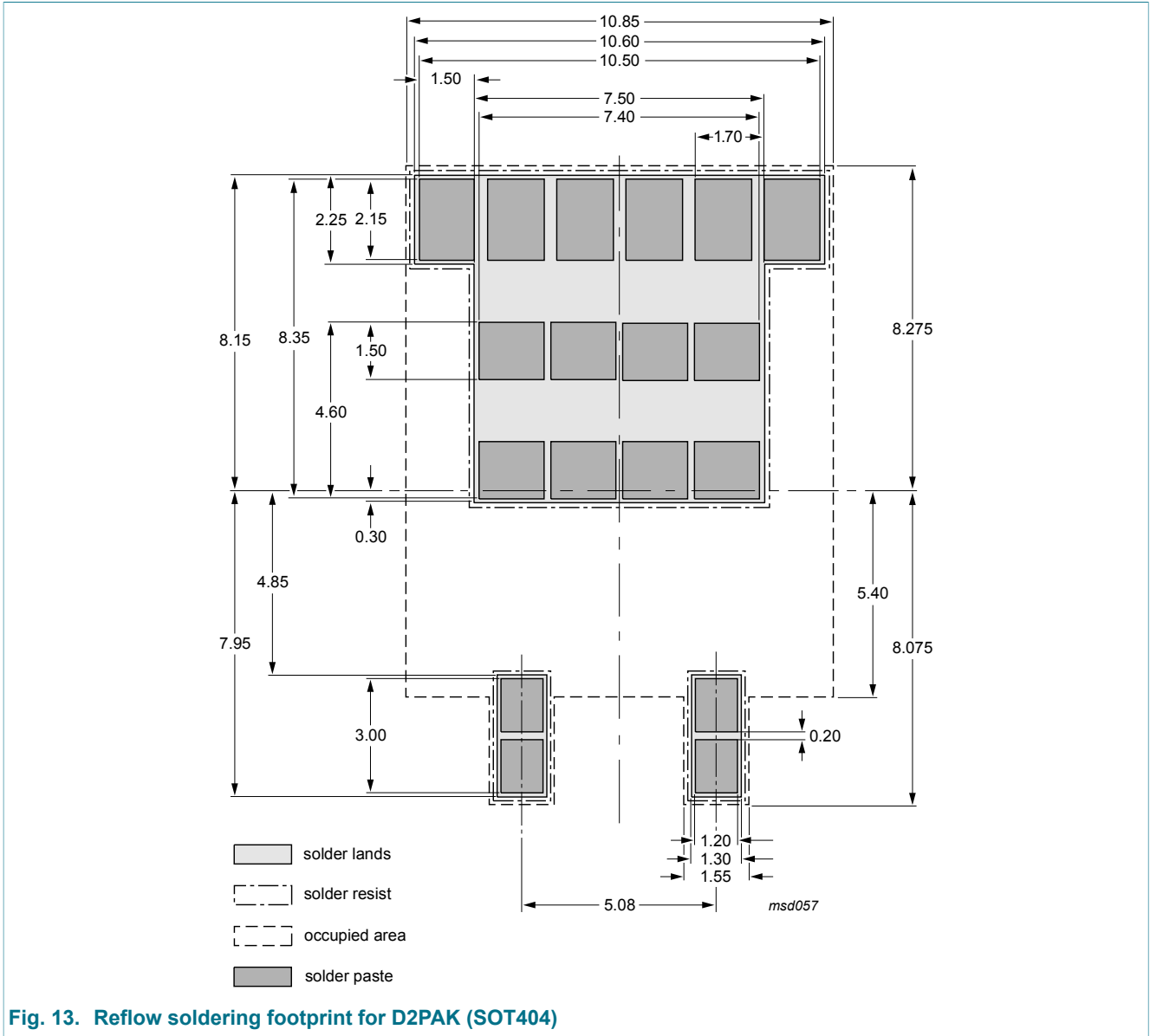


Fig. 13. Reflow soldering footprint for D2PAK (SOT404)
