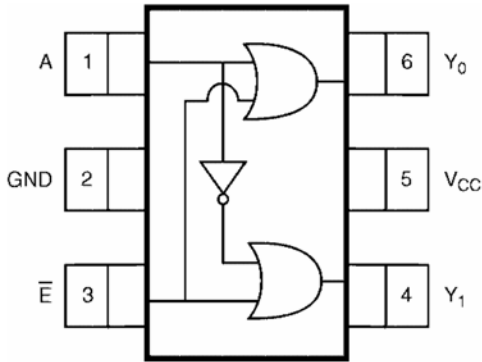


Figure 1. SC70 (Top View)

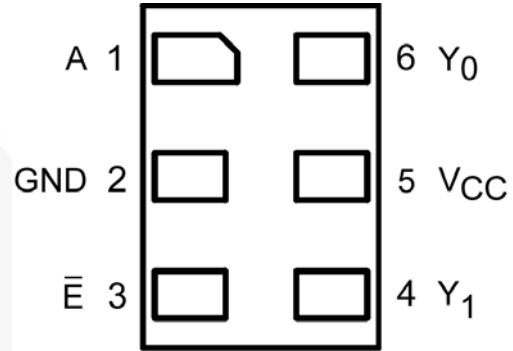


Figure 2. MicroPak™ (Top Through View)

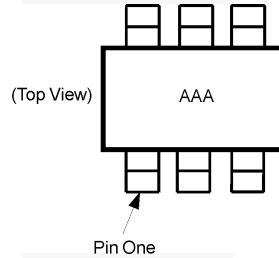


Figure 3. Pin 1 Orientation

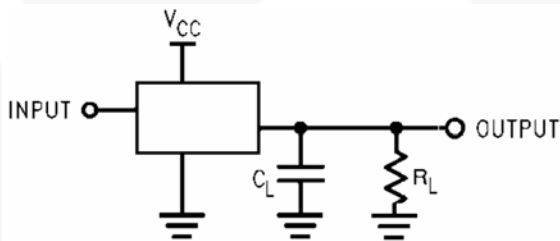

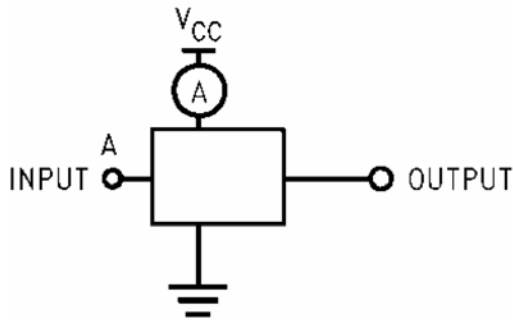

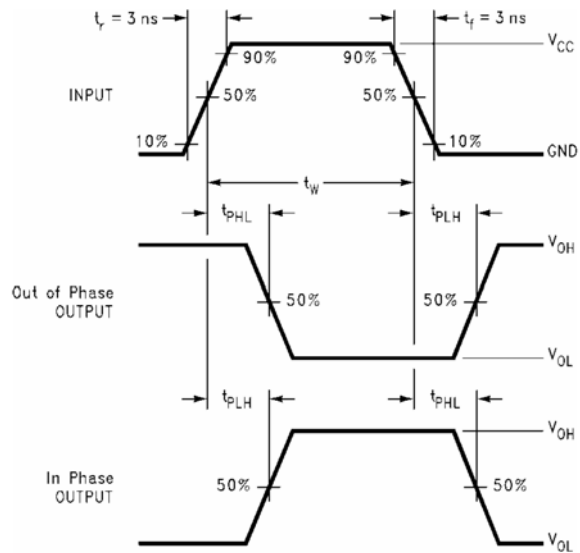

**Figure 5. I<sub>CCD</sub> Test Circuit**

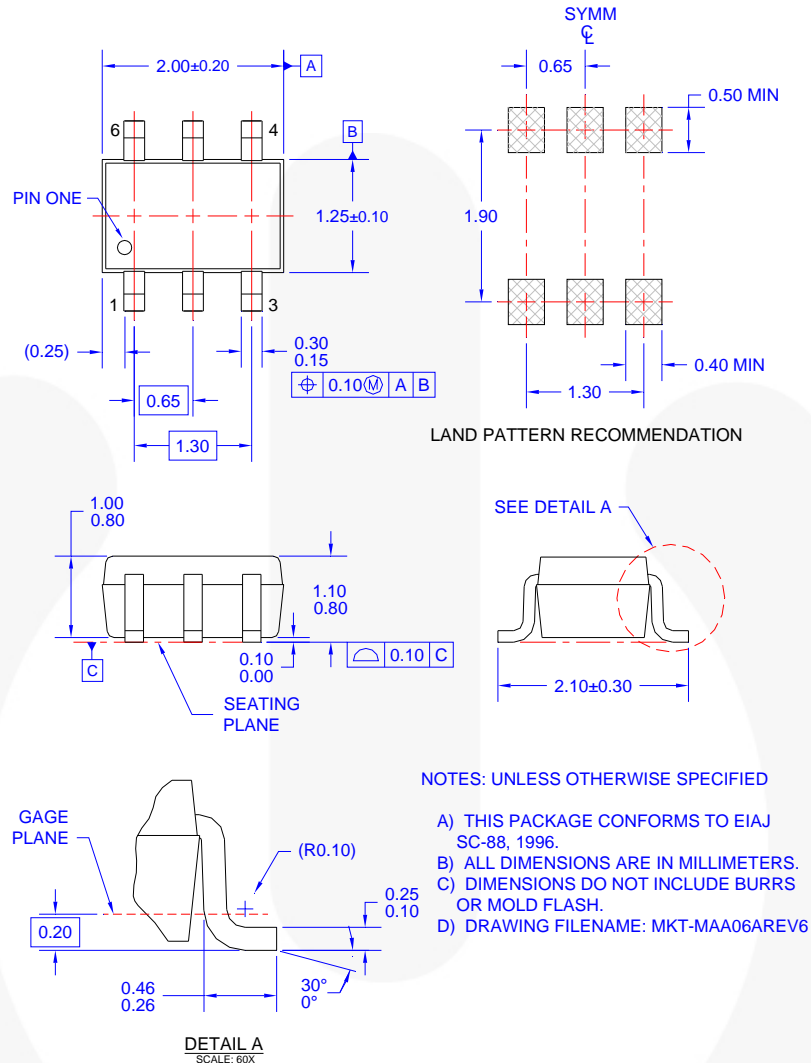


**Figure 6. AC Waveforms**

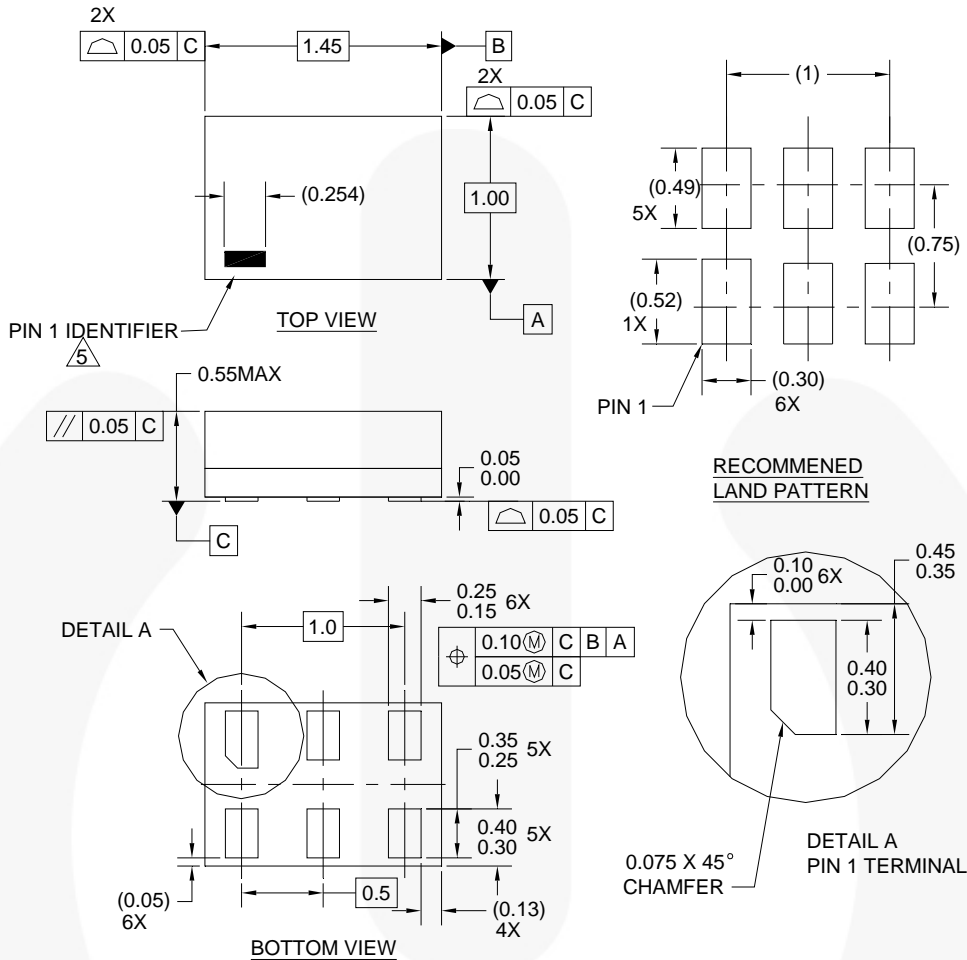

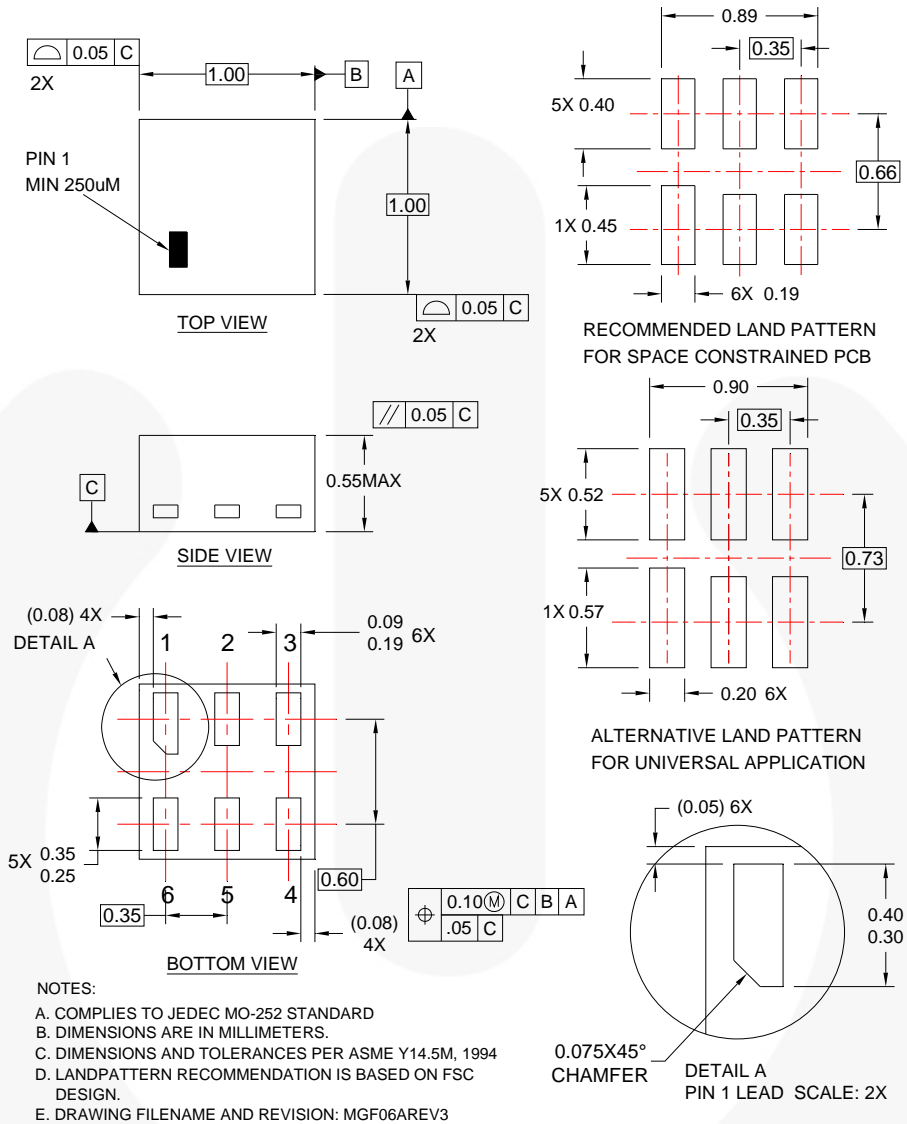


